



2014 Annual Report
Professor André Singer
President, Royal Anthropological Institute

This is the first annual report which I offer to Fellows, having taken over from Professor Clive Gamble in September 2014. In doing so, I should like to thank my predecessor for his extra-ordinarily creative period in office. It is a characteristic of the RAI – perhaps even the secret of its longevity – that it adds something as each decade goes by without taking away what is good and trusted about the old. In his case, we added a great deal, the fruits of which will be with us for many years to come.

Amongst the most spectacular of these is the instigation of biannual major conferences. At the end of May 2014, in co-operation with the Department of Oceania, Africa and the Americas, we gathered together in the Clore Centre of the British Museum to hold the second of these - a celebration, and a re-examination, of the place of photography in anthropology. Aply assisted too by the Anthropology Library at the BM, we welcomed some 474 delegates in 34 panels. All delegates who wished submitted a suite of fieldwork photos, which were then shown on an endless loop, enabling the whole conference to see specific examples of recent work. We should also thank the Wenner-Gren Foundation. Through their conference grant scheme, they very kindly offered support for five photographers – two from India, two from Latin America, and one from Africa, to join us and show their images.

At the RAI itself, we ran a full series of research seminars on a Wednesday evening. There have been some requests wondering whether we can hold seminars on other days of the week as well, and I am happy to confirm that we are working on this, so for example, in 2015 we have started in the spring to have seminars on a Friday, and in the autumn occasionally additionally on a Thursday.

Parallel to this, we also held a number of events outside the RAI. The ever-popular 'Reviewer meets reviewed' series continues at the BM, where likewise we celebrated the Huxley Lecture, delivered by Professor Tim Ingold. Indeed, on the same day Professor Ingold was bestowed in the afternoon the Huxley Medal, and in the morning a Knighthood from the Finish Ambassador, specifically Knight, First Class, of the Order of the White Rose of Finland. All of us at the RAI congratulate one our most distinguished Fellows upon this recognition.

Even though this was not a film festival year, we carried on presenting a number of events both at the RAI and further afield, which highlights the great importance that ethnographic film has for our institute. We have established a very creative link with the Department of Anthropology at USC, where I am an Adjunct Professor, whereby the Film Festival is shown in a reduced version there the following year of its taking place in the UK.

During the year, we were also pleased to welcome a new member of staff, Catherine Atkinson, who is working on the house archives, aided by the generosity of the Fagg Trust. Sadly, our Education and Communications Officer, Nafisa Fera, left the RAI in order to return to Canada. Nafisa contributed to the RAI not just in her expert handling of the position of Education Officer, but also through her boundless energy, talent for creating publicity material, and a series of very popular competitions. Her final major task for the RAI was to be in charge of 'front of house' for our Photography conference. That it went so well is in great part due to her efforts. She will be sorely missed. We welcome her successor, Emma Ford, and wish her well in her new role.

Fellows will recall that we were delighted to be able to launch the Anthropology A level in 2011, examined by the AQA Board. Very unfortunately, throughout 2014 we received indications from the AQA that they had concerns as to its possible take up, and we have subsequently heard from them that they are discontinuing it. The reason that they give for acting now is that the recent government reforms to the A level system mitigate against the investment which small subjects need if they are to be revised to fit with new specifications.

In response to this untimely news, the Education Committee has consulted widely and expressed its views in various media. However, OFQUAL (the government regulator) has since confirmed that it has accepted this decision by the AQA, and it appears that there is no immediate opportunity to reopen the debate. It is worth noting that the International Baccalaureate in Anthropology remains as active as ever, and is shortly to be relaunched with a revised specification.

On happier topics, I am most pleased to say that fellowship numbers continue to be buoyant. We have, thanks to our continuing an active programme of diversification of our income streams, been able for a further year to freeze membership subscriptions. There will be a point when they will have to rise, but we recognise the economic pressure that we are all under in these difficult times, and we are grateful to all Fellows for their support.

It only remains for me to thank all the staff for their outstanding work over the year, and also Council, committees and those who take part in our activities or write in our journals. I look forward keenly to the coming years.

Treasurer's Report

The RAI held a steady financial position in 2014, maintaining an overall surplus at the end of the year. Our equities investments continued to show signs of recovering, and the fund balance at the end of the year remained buoyant. We are again grateful to the generosity of the anonymous donor, and have received grants from the William Buller Fagg Trust, to whom we are indebted for their cordial additional support of the assistant archivist.

Our warnings from previous years remain. The instability of the financial world situation, and the more specific rise of 'open access' publishing means that the future income of the institute may be affected by a reduction from Wiley, our publishers. We have therefore put into place a programme of diversification of activities and their related income, in order to reduce the reliance of the RAI on any single source of funds. These activities include the our major conference series, continuing to work with the Alexander Street Press, and seeking donation from fellows of any unwanted anthropology books, that may either go to our library, or if already there, disposed of for the benefit of the RAI.

The diversification of our investments so as to include property continues. We now have one house purchased on behalf of the Esperanza Trust, which is rented out, and another purchased partly with general funds and partly with Horniman Funds, which is also rented out.

Income from Fellowship and membership continues to remain steady, showing a slight increase in numbers overall. Provided that we can successfully diversify in the coming years, we can continue to be cautiously optimistic about our financial position.
